Libertas Ministry Covenant

- I will honor the word of God by faithfully reading and obeying the scriptures, and integrating biblical truth into my personal growth and educational ministry.
- I will be faithful in worship and service as a member of a local church.
- I will seek to win the lost by a life of holiness and witness to the truth of the gospel.
- I will be diligent in fulfilling my call to ministry at Libertas by thorough preparation for my responsibilities.
- I will model submission to authority in my attitudes and actions toward the leaders God has placed before me.
- I will discipline myself by demonstrating a concern for personal godliness, care for those who are weak, love for those who are lost, and example for those who are growing. I will therefore refrain from practices that may cause a believer to stumble, that may offend an unbeliever, or that are detrimental to my body, such as indulgence in immoral dancing, immodest dress, gambling, immoral media, the use of tobacco, misuse of drugs, drunkenness, or any other thing they may bring reproach upon the Savior.
- I will exemplify God’s will as revealed in scripture for marital relationships, understanding that marriage, as defined by scripture, can only and ever be between one man and one woman. Furthermore, I will exemplify God’s will by maintaining moral purity and faithfulness, whether married or single, and, if married, by fidelity to marital vows and fulfillment of biblical roles in the home as husband/father or wife/mother.
- I will accept the instruction and counsel of the leaders God has placed before me.
- I will voluntarily resign my position if I cannot fulfill the above responsibilities.
